



Design Issues

- Not balancing earthwork by stage
- Incorrect base repair and concrete patching quantities
- Referencing BD Standards in plans
- Phase line interference issues
 - Shoring dimensions not considered
- Sufficient utility durations/scheduling not being built into pre-bid schedule
- SRL not appropriate for application



Design Issue – Shallow Rock Sockets






TYPICAL 3'-6" DIA. CAISSON SECTION WITH 3'-0" DIA. ROCK SOCKET






Shallow Rock Socket – 42" Caisson








Design Issue – Confined LOD
